IMPORTANT POINTS TO CONSIDER BEFORE USING THE DOG PARK:

- I understand that the dogs within the enclosure at the South Euclid Dog Park are off leash.
- I understand that the double-gate entrance to the enclosure must have at least one gate closed at all times.
- I understand that other dogs are curious about my dog and I will pay special attention to my dog when entering the park.
- I understand that dogs indulge in play and pack behavior; including showing dominance or submission, exuberant jumping and unbridled running.
- I understand that some of the dogs in the enclosure may be larger and stronger than a child, and I will not put children at unnecessary risk by bringing them into the enclosure.
- I understand that the Dog Park is for dogs and their handlers, and I have no reason to enter the enclosure without a dog.
- I understand that some dogs are aggressive about food and treats, and I will not bring food into the enclosure.
- I understand that I am responsible for my dog's needs, including water.
- I understand that outdoor play often involves dirt, dust and mud.
- I understand that I am responsible for cleaning up my dog's waste, and I will bring appropriate materials with me to do so.
- I understand that I enter the enclosure at my own risk.

SOUTH EUCLID DOG PARK RULES:

- Patrons and their dogs use the Dog Park at their own risk.
- Owners are responsible for all damages and/or injury inflicted by their dogs.
- No dogs declared dangerous under Ohio Law allowed (OH Rev. Code 955.22D).
- Children age 6 or under are prohibited from entering the Dog Park.
- Children ages 7 to 16 must be accompanied and supervised by an adult.
- Dogs must be leashed coming to and leaving the Dog Park.
- Dogs must be supervised by handler at all times.
- No more than 3 dogs per handler in the Dog Park at any time.
- No bicycles or portable pools in the Dog Park.
- Dogs in heat and dogs under 4 months of age are not permitted.
- Handler must clean up dog waste (S.E. City Ord. 505.18).
- Vicious or uncontrolled dogs must leave the Dog Park immediately.
- Dogs with communicable disease are not allowed.
- No aggressive dogs or excessive mounting allowed.
- Handler must have leash on his/her person at all times.
- No human food or dog treats allowed in the Dog Park.
- Dogs must wear current license and vaccination tags.
- The South Euclid Dog Park is open from dawn to dusk.
